[Gas Stoves: Health and Air Quality Impacts and Solutions.](#) Across the United States, millions of homes and apartments rely on gas appliances for heating and cooking. Burning gas in buildings is not only a threat to climate action but also to human health, as these appliances are sources of indoor air pollution. Gas stoves, particularly when unvented, can be a primary source of indoor air pollution. What's more, a robust body of scientific research shows the pollutants released by gas stoves can have negative health effects, often exacerbating respiratory conditions like asthma.



WHAT'S "UP" WITH THE NEWTON POWER CHOICE ELECTRIC CONTRACT?

Newton is "UP" to 80% renewables! - Sue Levy

Newton's environmental groups got quite busy in October when we learned that the Mayor was about to decide on the percentage of Class 1 New England renewable energy in the next Newton Power Choice electricity contract. In just three days, over 400 people signed an online Letter of Support and wrote inspiring messages encouraging the Mayor to increase the standard option from 62% to 100%. Advocates included Newton residents, Mothers Out Front Newton, youth leaders, City Counselors, Green Newton, 350 Newton, the EV Task Force, FUUSN's Climate Task Force and Engine 6.

When Mayor Fuller decided to set the standard option at 80% New England Class 1 renewables (local wind and solar, no biomass!) it became the highest percentage of renewables in any municipal aggregation electricity program. Mothers Out Front Newton joined all the advocacy groups to express our gratitude. Newton is also increasing the renewable content of our municipal electricity contract.
